We can best demonstrate our gratitude and esteem by making sure that our communities are good places in which to mature and grow older – places in which older people can participate to the fullest and can find the encouragement, acceptance, assistance, and services they need to continue to lead lives of independence and dignity. Now, Therefore, I, Ronald Reagan, President of the United States of America, do hereby proclaim August 21, 1988 as National Senior Citizens Day. I call upon the people of the United States to observe this day with appropriate ceremonies and activities."
